Missed Classes and/or Evaluations

Virtual Proctoring Information (if used in this course)

Online exam(s) within this course may use a virtual proctoring system. Please note that your completion of any such virtually proctored exam may be recorded via the virtual platform and subsequently reviewed by your instructor. Academic Integrity

Toronto Metropolitan University's <u>Policy 60 (the Academic Integrity policy)</u> applies to all students at the University. - 2. A grade reduction in the course greater than a zero on the work. (Note that this penalty can only be applied to course components worth 10% or less, and any additional penalty cannot exceed 10% of the final course grade. Students must be given prior notice that such a penalty will be assigned (e.g. in the course outline or on the assignment handout);
- 3. An F in the course;
- 4. More serious penalties up to and including expulsion from the University.
